**FEE SCHEDULES**

The Gillespie County Historical Society (Society) accepts requests for **digital copies of photographs** and for **dubbed copies of recorded oral histories** held in the collection. Additionally, the Society accepts requests for **document reproduction** services for research. To defray the costs of staff time (research, gathering, scanning, photocopying), as well as the costs of materials (CDs, DVDs, paper, copier, toner), the Society charges for the services listed below.

There is no *research and set-up fee* for the first **1 hour** on a single project. If further staff time is required, patrons will be given the option of continuing with the service for a fee of \$20 per hour (\$5 per ¼ hour), non-taxable. Reproduction time is one week. Patrons who continue with the service will need to complete and sign the **“Research Services”** form.

Payment must be made in full, and must include the cost of postage, prior to receiving the requested materials. Please remit payment to the **Gillespie County Historical Society, 325 W Main Street, Fredericksburg, Texas, 78624.**

All image and oral history fees are taxable.

  - Per image on 8 x 10 presentation paper.....\$10.00
  - Per image 11 x 17 presentation paper..... \$20.00
  - Up to 10 digital images (via Dropbox, additional fee if Museum purchased USB drive).....\$20.00
  
- **Book Edition**
  - Text Illustration (per image):
    - 2,000 published copies or less..... \$40.00
    - 2,001 – 5,000 published copies..... \$65.00
    - 5,001 – 10,000 published copies..... \$90.00
    - 10,001 – 24,999 published copies..... \$120.00
    - 25,000+ published copies (in one publication) .....\$150.00
  
- **Special Fees**
  - Broadcast Media: One Image up to 3-day use in news broadcasts..... No Charge

  - Display in Commercial Business or in a Local Publication:

      - Over 4 images negotiable depending on use
